INSTRUCTIONS

All certified real estate appraisers who plan to supervise trainees or who were supervising declared trainee(s) as of June 13, 2008 must complete this form and return to the Board. All certified appraisers who add a trainee to their supervision after June 13, 2008 must complete this form **prior to** beginning supervision.

The effective date of association (adding a trainee) or disassociation (removing a trainee) will be the date your request is received by the Board office or the date declared on the form, whichever is later. Dates of association and disassociation **cannot** be retroactive.

Certified appraisers may have no more than three trainees under supervision at one time. Within 30 days of declaring a trainee, all certified appraisers who wish to add a new trainee to their supervision must attend an education program approved by the Board regarding the role of a supervisor. Check the Board's website for further information.

This form may be filled out in your computer. Tab through the gray boxes to enter your information. All items must be completed. Appraisers may not attach a resume in lieu of completing this form or any portion thereof. The completed form may be mailed, faxed, or emailed to the Board Office.
