INSTRUCTIONS FOR LEVEL 1, 2, and 3 SECURITY GUARD RENEWAL APPLICATION

Application for renewal as a level 1, 2, or 3 Security Guard must include the following information and documentation:

- 1. Complete the Security Guard Renewal Application.
- 2. Any "Yes" answers for questions A through E on page 2 of the application require further information.
- 3. A "Yes" answer on question B requires a date of conviction; the city/county/judicial district/state of the action; a copy of all pertinent court documents and records; name of the judge; terms of probation; name of probation officer.
- 4. If you have used a different name, you must explain why and when and provide a copy of the legal name document.
- 5. Renewal fee payable to the Private Investigations Advisory Board. All fees are non-refundable.
- 6. Two recent 2" x 2" "Passport Type" photos stapled to the front page of the application. Do not use tape or paste.
- 7. Proof of required continuing education (CE) hours in the form of a certificate, training form, company stationary or college transcript. All CE hours must be earned during the renewal period.
- 8. RLD Release of Information form
- 9. Level 2 and 3 Security Guards must also submit a current copy of the electronic non-lethal device and/or current firearm certification form if applicable.
- 10. Background check.

All incomplete renewal applications will be returned to the registrant, which may result in an expired license and therefore cannot stand post until the license is renewed.

All applicants must use the following fingerprint process:

- Renewal applicants will need to **register** at https://www.cogentid.com/nm/index_NM.htm prior to going to an electronic fingerprinting location. ORI Lookup - NM920250Z
- Applicants may complete their fingerprinting at any 3M Cogent fingerprint location in the state of NM (map of locations are on Cogent web site). Appointments are not required.
- When the applicant arrives at the electronic fingerprinting location, they will need to provide the electronic fingerprinting technician with a registration number they received after registering online.
- The fee is \$44.00, which can be paid at the time of registration by credit card or at the fingerprinting site by cashier's check or money order.
- Background check results will be sent directly to the Private Investigations Board electronically.

Out-of-state applicants unable to complete the Livescan procedure in New Mexico, may mail inked fingerprint cards and the required \$44 fee to:
