1. Convene, Determination of Quorum and Introductions: Commissioners and Audiences Chairman Baker established that a quorum of the Commissioners was present convened the meeting at 9:30 a.m.

4. Directors Report – Director Martinez reported on the following items:

- Land Clark is the Deputy Director/Field Ops for CID and MHD
- Gloria Ruiz is now the CID/MHD Executive Assistant to the Director
- CID has advertised for (7) additional inspector positions
- Have made several trips to the southern part of the state to establish better relationships with local building officials. Have met with Las Cruces and Dona Ana building officials

- and various planning zoning and fire marshal representatives to clarify permitting, compliance investigation, inspections and communication questions.
- Creation of a "Building Official" email list to notify local officials about upcoming TAC's, code and policy changes in a more timely and effective way
- CID has held Division wide inspector meetings to discuss inspector issue in the field. These meetings have allowed the Division to move forward in a positive direction and have helped clarify internal policies to lead the Division to operate in a more functional manner.
- Have purchased (2) plan review workstations to allow users to send CID AutoCAD drawings or PDF documents of their plans for review.
- DOE checklist has been condensed to climate zone identification, HVAC load calculations that comply with section 405.6 of the IECC, design professional/owner affidavit.
- In April, the Bureau Chiefs, along with area inspectors and myself visited the URENCO facility. LES held a project update meeting and conducted a tour of the facility.
- Travelled to the Space Port with Bureau Chiefs to conduct a construction progress meeting and a timeline for the issuance of their Certificate of Occupancy.
- CID is providing Final Inspection Verification for phases of the project that do not require a CO. This assists the NMSA in meeting the contractual requirements with Virgin Galactic.
