1. Convene, Determination of Quorum and Introductions: Commissioners and Audience

Chairman Baker established that a quorum of the Commission was present and convened the meeting at 9:35 a.m. **ATTENDING** this meeting were:

2. Approve Agenda

3. Public Comment

4. Directors Report

Director Martinez reported as follows:

- Legislative Roundup: **HB 274 (Cook) Manufactured Housing Committee Makeup** passed to the change the composition of the Manufactured Housing Committee to create a better representation of the industry and stake holders.
- **HB 279 (Stewart) Solar Collector Permitting** passed to add rule promulgation and definition of trade bureau having jurisdiction within the Construction Industries Division for the permitting of small solar collectors. This bill will help to streamline

the small solar collector permitting process, provide clarity to the definition of solar generating equipment and clarify the trade bureau having jurisdiction, including licensing scope for permitting and inspections.

- HB 348 (Rodella)/SB 249 (Papen) Statewide Inspector Certification passed to amend the Construction Industries Licensing Act as it relates to inspector certifications creating statewide Inspectors certificates, establishes inspector qualifications, establishes Certified Building Officials, allows for the utilization of MOU's for shared inspection resources between municipalities and counties, and repeals section 60-13-43 NMSA 1978 (BEING LAWS 1967, CHAPTER 199, SECTION 51, AS AMENDED).
- In February, energy training was held for the Las Cruces Home Builders Association. This was a huge success, thanks to Fermin Aragon, Kelly Hunt, Jerome Baca, Richard Lucero and Jesus Carrasco on conducting informative presentations on recent code changes with the adoption of the 2009 IECC/NMECC.
- Oil and Gas Permit Streamlining A very successful meeting to discuss streamlining the oil field permitting process was held at the Legislature with Senator Leavell and CID staff. The end result will be a simplified permitting process for electrical work that still takes into account safety concerns of the utility and the Division. The industry was appreciative for the working session and has worked with the Division to collect feedback on the permitting proposal throughout the state.
- Procedures established since last meeting are: DPR plan intake procedure and Complaint central intake procedure.
