

NM RLD |AGD |HOURS OF SERVICE FOR ALCOHOLIC BEVERAGES

Note: Sunday Sales by the drink and/or package are only permitted in those local option districts in which Sunday Sales have been approved by the voter. The only exceptions are the small manufacturers (NM Winegrowers, Craft Distillers and Small Brewers) – their Sunday sales by package or by drink are not subject to local option district elections.

RESTAURANTS

Sales by The Drink Only, between the hours of **7:00am to 11:00pm** or until sales and service of food ceases, whichever is earlier, and with a Sunday Sales Permit for the sale of alcoholic beverages by the drink on licensed premises on **Sundays**, between the hours of **11:00am to 11:00pm**, or until sales and service of food ceases, whichever is earlier.

CRAFT DISTILLERS AND SMALL BREWERS

Sales by the Drink and by Package: sell and serve between the hours of **7:00am to 2:00am**. With a Sunday Sales Permit for the sale, service, or consumption of alcoholic beverages on a licensed premises on **Sundays**, between the hours of **noon and midnight**.

WINEGROWERS

Sales by the Drink and by Package: sell and serve between the hours of **7:00am to midnight**. With a Sunday Sales Permit for the sale, service, or consumption of alcoholic beverages on a licensed premises on **Sundays**, between the hours of **noon and midnight**.

DISPENSER, CLUB, GOVERNMENTAL and BED AND BREAKFAST

Sales by the Drink: sell and serve between the hours of **7:00am to 2:00am**. With a Sunday Sales Permit for the sale, service, or consumption of alcoholic beverages by the drink on a licensed premises on **Sundays**, between the hours of **11:00am and midnight**.

DISPENSER

Sales by Package (*only applies to licenses that retain their package privileges*): sale of alcoholic beverages for off-premises consumption, **between the hours of 7:00am to midnight**. With a Sunday sales permit for the sale of alcoholic beverages in unbroken packages for off-premises consumption on **Sundays**, between the hours of **noon and midnight**.

RETAILERS

Sales by Package: sale of alcoholic beverages for off-premises consumption, between the hours of **7:00am and midnight**. With a Sunday sales permit for the sale of alcoholic beverages in unbroken packages for off-premises consumption on **Sundays**, between the hours of **noon and midnight**.

EXCEPTIONS /HOLIDAYS

CHRISTMAS

Dispenser, Canopy, Restaurant, Club, Small Brewer, Craft Distiller, Bed and Breakfasts, and Governmental licensees may sell serve or allow the consumption of alcoholic beverages by the Drink on licensed premises **from noon until 10:00pm**, provided that the Licensee **also has a valid food establishment permit** – otherwise no Christmas sales allowed.

When Christmas falls on a Sunday, the above sales are only permitted in those local option districts that have voted to allow Sunday sales. (This rule also applies to Small Brewers and Craft Distillers)

Winegrowers' sale or service of alcoholic beverages is unaffected by Christmas Day.

No Package Sales allowed on Christmas Day. Wholesalers cannot deliver alcoholic beverages.

NEW YEARS EVE

Sales by the Drink: when New Year's Eve falls on a Sunday, the following licensees are able to remain open until 2:00am: Dispensers, Clubs, Governmental, Bed and Breakfasts, and Small Brewers and Craft Distillers with their offsite locations.

Restaurants, and Winegrowers, including their offsite locations will close at their usual times.

VOTING /ELECTION DAYS

No longer affect hours of sales and/or service of alcoholic beverages.
