Chairman Baker & Members of the Construction Industries Commission **Director's Update:**

Good Morning! Thank you for the opportunity to report to you today the events of CID for the months of November and December, 2015.

As we move in to a new year, 2016, CID is continuing its efforts to better the efficiency of the agency in regards to the permitting and inspection scheduling processes. The implementation of the new Accela software is only part of our pursuit for more efficiency.

We are working closely with local jurisdictions in regards to training and support.. We are improving the communications between the local jurisdictions and the state, especially in the area of code related interpretations and enforcement.

We are working more closely with the Attorney General's office, not only with the attorney from the Attorney General's office representing the Commission, but also with the prosecuting attorneys assigned by the Attorney's General Office to CID to ensure that legitimate complaints are addressed in a timely manner.

As you know, the 2016 Legislative Session began yesterday, January 19th and will run through February 18, 2016. The majority of the Session will deal with budget issues.

The New Mexico Regulation and Licensing Department (RLD) has a process in place so that agencies can respond through an FIR (Fiscal Impact Report) to each bill. We have a team in place consisting of myself, Rick Martinez, our Financial Manager, and Ms. Sally Galanter, legal counsel for CID to review and respond accordingly.

I also listed the Bureau Chiefs as "experts" for any specific comments and/or research that may be required as we assemble our responses. We have a 24 hour turn-around time for all FIR's so it is extremely important that we respond to each bill thoroughly, accurately, and efficiently.

CID continues to reduce its vacancy rate through new hires. We currently have 5 inspector positions either posted or listed for hiring.

Chris Archuleta continues to work with all Bureau Chiefs and other CID Staff in the implementation of the Accela software. Our sincere thanks to the IT Department of RLD for their unending support to both CID and MHD as we continue educating our customers regarding the use of the on-line permitting process.

Agency wide we continue to conduct Trainings with all inspectors in all Bureaus: General Building, Mechanical, Electrical, LP Gas and MHD. Our own Jason Davis, Electrical Inspector, has been instrumental in leading several in-house training sessions to all Bureaus.

We now have kiosks in the Albuquerque and Santa Fe offices so walk-ins can apply for their permits on-line themselves, and we have individuals available who can guide them through the on-line process. We will be installing a kiosk in the Las Cruces this month.



BUREAU UPDATES

GENERAL CONSTRUCTION BUREAU – November and December, 2015

Martin Romero - Bureau Chief

- The CID Building inspector position for the Gallup, Grants, Farmington area was filled with the hiring of Joseph Herrera on November 23, 2015. Joseph brings twenty five years of experience in the construction trade in contracting, and inspections.
- Brian Houghtalin who was recently certified as an Electrical inspector for Chaves County has requested a multiple certification as a secondary discipline. The request was approved in accordance with NMAC 14.6.5.8 inspectors.
- Multiple inspector Mauro Rosales continues to work with Chief Inspector Tom Sanchez in the Northern region of the state on Plumbing, and Mechanical inspections.
- A town hall meeting was held on December 7, 2015 with the Town of Taos Council, City Manager Rick Bellis, Planning Department Staff, CID and Contractors were present to discuss the building permit process and to learn about the on-line submission process, and inspections. Since that meeting, the Town of Taos has requested, in writing, that CID State of NM take back the responsibility of all permitting and inspections.
- A Meeting was held with the city of Espanola City Manager, Kelly Duran, and the Planning Director, Patrick Nicholson on our processes within CID regarding permits and inspections. It was explained to them that if this is the direction that they want to go, CID, State of NM would need a letter from the city manager requesting our services. A letter was received on December 21, 2015, requesting our services; therefore, permits, and inspections under the responsibility and jurisdiction of CID NM began on January 4, 2016.

MECHANICAL BUREAU - November and December, 2016

J.T. Baca - Bureau Chief

 Bureau Chief J.T. Baca along with Bureau Chiefs Hunt and Romero, and Director Pat McMurray met with Chris Huchton, Facility Maintenance Manager & Operations Support Manager for NM Public School Facilities Authority and a delegation of individuals regarding annual permit scope, licensing requirements and training and certification for public schools maintenance personnel. Other attendees Included, Bob Gorrell, PSFA Director, Mike Puelle, and Vicky Mora with AGC. The meeting was successful in bringing to the table the need to evaluate the impact of the CID rules and regulations regarding permits, scope of work limits, inspections and licensing requirements for PSFA maintenance programs.

- Bureau Chief J.T. Baca and Mechanical TAC Subcommittee member, David Wall and Chief Inspector Tamara Kuykendall met with PSI Proctors to provide a workshop concerning possible improvements in regards to the way the CID Mechanical and Plumbing practical exams are administered The goal/purpose was to continually improve the journeyman practical test takers experience with PSI and CID and to provide a fair assessment for the candidate. The proctors provided feedback that was beneficial and will be considered in making changes in the exam content.
- The Mechanical Bureau held its regular TAC meeting on December 16^{th.} A few of the agenda items included an update on Senate Bill Memorial 27 (Fire Dampers) where a final draft of proposed rule was presented by Vince Alvarado. Product review for approval of a new pure form of poly based pipe for water systems, CEU course review and a presentation by City of Albuquerque Chief Plumbing Inspector Roger Coble was provided to the TAC regarding the current city code adoption and changes to the city ordinance.

ELECTRICAL BUREAU - November and December, 2016

Kelly Hunt - Bureau Chief

- We have re-instated the quarterly electrical inspectors meetings for 2016 and look forward to attendance by all area political subdivision electrical jurisdictions representatives.
- Sickness and Snow precluded our December Electrical Quarterly meetings, however we did keep up with all necessary business to include ACCELA training utilizing multiple conference call sessions.
- Statewide Oil & Gas inspections are keeping a steady pace even though news of industry
 wide cutbacks continues to grow. Recently, several existing, older, oil and gas sites, still
 in production, have been inspected and some life and property safety issues were
 discovered. We are working with the industry/contractors at these sites to ensure
 effort to bring them, and keep them, in compliance continues.
- Overtime for the SE area inspections, driven by the Oil Patch was re-instated Thursday December 17th by Director McMurray in communication with Superintendent Unthank based upon request from industry.
- Chavez County successfully hired a new NM State Electrical Inspector; and are now performing their own electrical inspections.

Inspector Joseph Martinez has successfully relocated to the Santa Fe area to take over retired inspector Pat Gilligan's territory, NE of SF, to include the Las Vegas and Mora municipalities along with San Miguel, Harding and Mora Counties.
