**RECEIVER'S JULY, 2018, MONTHLY REPORT**

COMES NOW, Christopher Moya, court-appointed Receiver for Desert State Life Management (DSLML) and Acting Director of the Financial Institutions Division (FID) of the New Mexico Regulation and Licensing Department, by and through the FID's attorney of record, Kevin A. Graham, and provides the Court with the following Receiver's July, 2018, Monthly Report.

**CONTINUING ACTIVITIES OF THE RECEIVERSHIP**

1. Funds: The Receiver is in control of the following bank accounts and funds in the name of DSLML and account balances as of June 28, 2018, stood at the following amounts:

2. Examination of Records and Accounts:

Efforts continue to digitally scan the records of all client accounts of DSLM that were open as of the date of the company being taken into receivership. At present approximately half of the client records in the possession of the Receiver have been digitally scanned. The current target date for the completion of scanning of all client records of DSLM is the end of November, 2018. As has been previously noted, efforts to organize the DSLM corporate records and verify data have led to numerous determinations that certain vital records are missing from the DSLM files and/or that records containing incorrect and intentionally falsified records were created.

3. Necessity of Successor Trustees Clients:

The Receiver is engaged in ongoing efforts to transfer trust accounts currently under the interim trusteeship of the trustee over to appropriate, permanent trustees. Discussions have begun with a certified New Mexico non-profit trust company to take over trustee duties for those trusts that qualify as “special needs” trusts under relevant federal Medicaid and Social Security laws.

The Receiver anticipates the transfer of trust accounts to the non-profit trust company to be carried out in steps, with a few of the most active trust accounts being transferred first, and then additional trust accounts being transferred over a period of the next few months. As has been noted in the prior monthly reports, the Receiver has repeatedly attempted to notify all trust beneficiaries (or their appropriate guardians, conservators or legal representatives) of the necessity to find successor trustees to take over responsibility as trustee for their trust accounts, but only a handful of trust beneficiaries or the representatives have responded to the Receiver on this issue. Due to the press of other business for the Receiver and the relevant staff of the FID over the past month, there has been limited progress on the transfer of trust accounts, but effecting the transfer of the trusts to a permanent trustee remains a priority of the Receiver.

4. Insurance Policies/Coverage for DSLM: The Receiver has continued to be in contact with representatives and/or counsel for the three (3) insurance companies that had policies in effect with DSLM on or shortly before the filing of the receivership action in the above-captioned matter. The Receiver has encouraged all clients of DSLM to consult with their personal legal advisors and counsel regarding their legal rights and any claims they may have against the insurance coverage for DSLM. NOTE: The Receiver is in the process of reviewing all relevant legal issues related to the Receiver's authority under the terms of the individual trusts, the Uniform Trust Code and the New Mexico Receiver's Act to retain legal counsel to represent the interests of each of the individual trusts in regards to pursuing insurance claims under the insurance policies providing coverage for DSLM and/or any officers, directors or employees of DSLM. An added legal complexity on this subject may arise due to the nature of the Receiver's status as employee of the State of New Mexico, so that issue will have to be fully researched and considered as well. The Receiver anticipates providing more information to the Court on this matter in the coming months.

5. Federal Criminal Prosecution: The Receiver continues to work in coordination with the United States Attorney's Office for the District of New Mexico to obtain restitution orders in the federal criminal case against Paul A. Donisthorpe. To the Receiver's knowledge, the sentencing date for Case No. 2017-3311 JB, United States of America v. Paul A. Donisthorpe, still has not been set.
