**SUPERINTENDENT'S ORDER DENYING
SECURITY GUARD REGISTRATION**

THIS MATTER came before the Hearing Officer at a hearing on June 12, 2018 on the merits for a decision in the above referenced case. Following the hearing, Hearing Officer, David Peach recommended that the Respondent's registration as a Security Guard Registration Level 1 be approved on a probationary period under the condition that any future criminal infractions to include misdemeanors or greater be immediately (within 24 hours) be reported to the Regulation and Licensing Department (the "Department"), and would be grounds for possible revocation.

FINDING OF FACT

The Superintendent, having familiarized himself with the record of the proceedings, including the Hearing Officer's Report, hereby makes the following findings of fact:

1. Respondent submitted an application for registration as a Security Guard Registration Level 1 to the Department on September 21, 2017.
2. By judgment filed March 18, 2005, Respondent was convicted of Conspiracy to Commit Trafficking by Manufacture, a third degree felony.
3. By judgment filed April 9, 2010, Respondent was convicted of one (1) count of "Dealing in Credit Cards of Another," a third degree felony, and four (4) counts of Theft of Identity, a fourth degree felony.

A copy of the Hearing Officer's Report is attached hereto.

Following a hearing, a person aggrieved by the adverse final order of the Superintendent may appeal to the District Court pursuant to the provisions of §12-8-16 and §39-3-1.1 NMSA 1978. The commencement of appellate proceedings does not, unless specifically ordered by the court, operate as a stay of the Superintendent's order.

THEREFORE, it is ordered that Helen Margaret Bates's Registration as a Level One Security Guard be denied.


