Waiver requested to permit Walgreens to deploy an automated system as a tele-pharmacy in the Emergency Department of Memorial Medical Center located at 2450 S Telshor Blvd, Las Cruces NM which would allow patients to access pharmacy services (patient counselling, drug utilization review and medication dispensing) both during and after-hours onsite. The time requested for this waiver is 2 years.

Expected public benefit as a result of the waiver:

The request is to allow the automated system (Walgreens Prescription Center) to be deployed in the Memorial Hospital ED will promote public health by providing immediate onsite access to pharmacy services, and by ensuring that patients will have direct access to a pharmacist in environments where a pharmacist-guided prescription dispensing is otherwise unavailable. The geographic area surrounding the Memorial ED has few 24-hour pharmacies in the immediate area. Also, Walgreens is attempting to improve adherence and compliance by providing patients immediate access to pharmacy service and medication dispensing at the point of care.
