

# TITLE 16OCCUPATIONAL AND PROFESSIONAL LICENSINGCHAPTER 7MASSAGE THERAPISTSPART 3FEES

**16.7.3.1 ISSUING AGENCY:** Regulation and Licensing Department, Massage Therapy Board [7-28-96; 6-1-99; 16.7.3.1 NMAC - Rn & A, 16 NMAC 7.3.1, 06-28-01; A, 06-24-2005]

**16.7.3.2 SCOPE:** This part applies to licensees, registrants, and applicants for licensure and registration. [7-28-96; 16.7.3.2 NMAC - Rn, 16 NMAC 7.3.2, 06-28-01]

**16.7.3.3 STATUTORY AUTHORITY:** This part is adopted pursuant to the Massage Therapy Practice Act, Section 61-12C-20.

**16.7.3.4 DURATION:** Permanent.

**16.7.3.5 EFFECTIVE DATE:** July 28, 1996, unless a later date is cited at the end of a section. [7-28-96; 16.7.3.5 NMAC - Rn, 16 NMAC 7.3.5, 06-28-01; A, 06-24-2005]

**16.7.3.6 OBJECTIVE:** This part is to establish the required fees for application, examination, licensure, registration, renewal, reactivation of a license, duplicate/replacement license or certificate, verification of licensure or registration, and such other fees as determined by the board. [7-28-96; 16.7.3.6 NMAC - Rn, 16 NMAC 7.3.6, 06-28-01]

**16.7.3.7 DEFINITIONS:** "**Inactive status**" occurs when a massage therapist's license or massage therapist instructor's registration is not renewed by the end of the grace period allowed for in the licensee's or registrant's renewal cycle. A license or registration can also be placed on inactive status for a period of two years. If the inactive license or registration is not reactivated within those two years, it automatically expires, lapses and becomes null and void.

- (**1**) Application : \$75.00
- (2) Initial license: Pro-rated \$5.00/mo.
- (3) Biennial renewal: \$125.00
- (4) Late renewal penalty: \$75.00
- (5) Renewal during the grace period: \$125.00 plus late renewal penalty fee
- (6) Reactivation from inactive status: \$125.00 plus late renewal penalty fee
- (7) Review fee for "other" elective courses as provided in 16.7.4.14 NMAC): \$50.00

#### **B.** Massage therapy instructor:

- (1) Registration: \$50.00
- (2) Biennial renewal school based: \$25.00
- (3) Biennial renewal independent: \$50.00
- (4) Late renewal penalty: \$75.00
- (5) Renewal during the grace period: \$50.00 plus late renewal penalty
- (6) Reactivation from inactive status: \$50.00 plus late renewal penalty fee

#### Massage therapy school:

- (1) Registration: \$50.00
- (2) Annual renewal: \$50.00
- (3) Late renewal penalty: \$75.00
- (4) Application review: \$400.00
- (5) Curriculum change review: \$50.00

(1) Temporary license: \$25.00



- (2) Visiting massage therapy instructor: \$50.00
- (3) Lists: \$50.00
- (4) Labels: \$75.00
- (5) Other administrative fees (at the discretion of the board and/or board administrator) not to exceed
